### Canada Disability Benefit Act



Since 2015, our Government has worked tirelessly to lay a strong foundation that ensures the inclusion of persons with disabilities. Historically, Canadians with disabilities have been affected by economic disparities and are twice as likely to live in poverty. That's why our Government has been working to build a more accessible and inclusive Canada by introducing new legislation that would establish the framework for a new Canada Disability Benefit.

A cornerstone of our Disability Inclusion Action Plan, the Canada Disability Benefit would supplement, not replace, existing federal and provincial-territorial supports, lifting hundreds of thousands of persons with disabilities out of poverty. The Canada Disability Benefit will help address the longstanding financial hardship felt by persons with disabilities, creating a more disability-inclusive economy and society.

We know that persons with disabilities face unique barriers, especially regarding health, social well-being, and financial security. I have heard from concerned parents in our communities who want to ensure their children with disabilities have the best chance at success. It's stories like theirs that motivate me.

People with disabilities need healthcare and health programs for the same reason everyone else does - to stay well, active, and a part of the community. As policymakers, it is our responsibility to support the Canada Disability Benefit Act (Bill C-22) to support those living with a disability to enjoy a full life.

I gave a speech in the House of Commons to share how the Canada Disability Benefit will help working-age persons with disabilities. I am proud to support this bill.

# Affordability

Canadians are feeling the rising cost of living, particularly through higher food prices and rent. We know inflation is a global challenge, and we are helping Canadians by putting more money back in their pockets.

We announced additional supports that will help make your life more affordable:

- Dental Care for Children Under 12
- Doubling the GST Tax Credit
- \$500 for Low-income Renters
- Cutting child care fees in half by the end of the year
- Delivering the Canada Child Benefit which helps over 20,000 families in Kitchener-Conestoga
- Enhancing the Canada Workers Benefit
