Our government is providing a \$1 million repayable investment to help them scale up and to create nore jobs here in Kitchener Conestoga.



#### Safe Sport in Canada

As a member of the Heritage Committee, I am part of a study to review how we can hold sports organizations accountable for protecting athletes from abuse.

I have heard from athletes, parents, and coaches, all wanting to improve the current systems. We are working on setting up a framework that will make sports safer for all participants in Canada.

As parents, we are as dedicated to protecting our children as they are committed to their sports. Participation in sports provides numerous benefits for children of all ages; improved physical health, socialization, and character development, to name a few. Sports should create a safe and supportive environment that fosters a child's growth, setting them on a path to a healthier and more fulfilling life.

#### Soccer Canada

In a separate study, we heard testimony from players of Canada's Olympic Women's Soccer Team, including team captain Christine Sinclair.

Members of this gold medal-winning team are looking for pay equity and equity of resources and support. Ahead of the World Cup in Australia and New Zealand this summer, they seek the same backing the men's team received before last year's World Cup in Qatar. The men's team earns five times more than the reigning champion women's team. The Heritage committee seeks to highlight these inequities and advocate for change.

Women athletes inspire and empower young girls by breaking down barriers and challenging gender stereotypes. Women athletes demonstrate the strength, discipline and resilience needed to succeed through their achievements.

### A Battle For Local News

In Kitchener-Conestoga, our community stays connected through our trusted local newspapers like the Kitchener Citizen, Waterloo Region Record, New Hamburg Independent, Woolwich Observer and the Wilmot-Tavistock Gazette. These credible news organizations deliver essential information with a local lens that can't be found in national newspapers.

For years, local newspapers have struggled to stay afloat in the digital age as many people turn to online sources for their news. This has resulted in a decline in print circulation and ad revenue for many newspapers, making it difficult to sustain their operations.

Tech giants like Google and Facebook have profited immensely from using local newspaper content on their platforms. By using algorithms to display news articles and related content, Google and Facebook have been able to drive traffic to their sites and generate significant ad revenue.

It's only fair that these tech giants share a portion of this revenue with the local newspapers whose content they use to attract readers. This revenue could go a long way in helping local outlets survive and continue to provide quality journalism to their communities.

Our government has introduced Bill C-18, the Online News Act, to support journalists and level the playing field between digital platforms and news publishers. This legislation will require tech giants to fairly compensate publishers and journalists for the content shared on their platforms.

With Bill C-18, the government does not decide who gets money or how much they get. C-18 promotes voluntary commercial agreements between digital platforms and news outlets. It is not a government bail-out for publishers. Some opponents of Bill C-18 claim it will lead to censorship and restrict free speech. These claims are simply not true. The bill does not restrict access to news content or limit free speech. Instead, it aims to ensure that local newspapers are compensated for their work and that the digital marketplace operates fairly.

In response to this proposed legislation, now being studied in the Senate after passing in the House of Commons, Google has begun restricting access to news in Canada, blocking the news we see online. Facebook says they will block news content in Canada on Facebook and Instagram if C-18 passes. This is unacceptable. Their threats send the message that Google and Facebook would instead prevent Canadians from accessing news than pay their fair share of ad revenue to newspapers for using their content.

News content is not free. Canadian publishers must be adequately compensated for their work as they deliver essential information to benefit our democracy and our communities. Those who financially benefit from Canadian news must also contribute to it.

I will continue to advocate for supports to local news outlets. And I will always support quality, fact-based, independent, and local Canadian journalism.

## Ottawa Update

## **Agriculture Committee**

Food inflation remains stubbornly high, and we are all feeling the pinch when we head to our local grocery store. There are several global issues affecting food prices including pandemic disruptions, the war in Ukraine, the climate crisis, supply chain issues and labour shortages.

As a member of the Committee on Agriculture and Agri-Food, we are undertaking a study on inflation in the food supply chain and the cost of groceries going up. Increases in grocery prices are outpacing the overall rate of inflation. Food is the third largest expense for Canadian households, and because food is a fundamental need, households have less flexibility to reduce their spending in this area compared to others.

Our committee has heard from the Competition Bureau about their role in ensuring fair practices in the grocery sector. Prices have shown a tendency to be asymmetric or "sticky," with adjustments to increases occurring faster than decreases. In other words, prices go up fast, and come down slow.

Food prices play a critical role in determining the affordability and accessibility of food, which in turn affects food insecurity and health outcomes. When food prices rise, lower-income individuals and families struggle to afford nutritious food.

We are also working towards a Grocery Code of Conduct – Canada is creating a governing body to oversee the industry and create accountability. This code will add transparency and certainty, and ensure fair dealings throughout the sector, protecting our independent grocers and farmers. Australia and the United Kingdom have imposed similar codes, and Canada is one step closer to joining that list.

## Health Care

As Canadians, we value our universal public health care system. Health care is one of the top issues I hear about in discussions with our community.

I have had many conversations with health care workers in Kitchener-Conestoga who spend their time making a difference in others' lives. I have heard from our students who are passionate about starting a career in health care and the educators who proudly train our healthcare workers of the future. I have heard from people who are waiting for surgeries that have been postponed or cancelled and from families who don't have a family doctor or nurse practitioner.

Our health care system, and the workers who uphold it, are under enormous strain and need immediate action to deliver better care for Canadians. Our federal government has met with all 13 premiers to discuss the issues surrounding our healthcare system. One priority unanimously agreed upon is ensuring access to healthcare based on need, not on the ability to pay.

That's why we are investing almost \$200 billion over the next ten years into improving the healthcare system.

This plan includes: making sure Canadians have access to family doctors and nurse practitioners; supporting the people who power our health care system and reduce backlogs; helping people get mental health care and substance use supports; and ensuring your health information is available to you and your health providers – so you get the best quality care.

Our government will keep working to create a better and safer future that ensures access to health care is based on need, not on the ability to pay - a future where all citizens of Kitchener-Conestoga can access the supports and services for their health and well-being.

#### Canada Child Benefit Tax
